## Acknowledgements

There are two major influences behind this book. The first is the work of John Sinclair and his COBUILD research team over the last twenty-five years. This research is changing the way language is viewed, in particular the relationship between lexis and grammar. One outcome of the COBUILD research is the work on pattern grammar by Gill Francis, Susan Hunston and Elizabeth Manning which features heavily in Chapter 7.

The second major influence is the work of Michael Halliday. The whole view of language as a meaning system, which informs this book, comes from Halliday. I have attempted to describe language as a functional system, and this again derives from Halliday. In addition to this general influence the detail of very much of the description offered here is based closely on Halliday's work. Michael generously offered to read and comment on a near final version of the book. Most of his comments have been incorporated, although we still differ on the general approach in Chapter 5.

Indeed, without her the book might not have been written at all.
